Member states he has drawn up papers and named a friend to be guardian to the children when he passes. His friend visits frequently.

The member has had multiple DCF involvements due to issues with the children, ex-significant other-the children's mother, his delusions and paranoia.

He is established with a PCP and sees her routinely.

2/8/21: Member stopped Oncology- the oncologist would not acknowledge his delusions.

3/5/21: Member stopped mental health therapy- member states she stands firm on the diagnosis of paranoid schizophrenia which he denies.

3/11/20- last cardiologist visit. Member refuses to attend an appointment.

4/27/20- the last CT he has had, showed enlarging masses bilateral lungs.

4/2021: PCP ordered brain CT r/o mets to the brain. It was denied so an MRI was ordered. The member declined the MRI.

5/3/21: Member started hospice services.

5/12/21: Requested assessment for PD Waiver-crisis exception. Member was approved on 5/20/21. (Previous assessment, August 2019, member did not meet criteria for the wait list).

The member refuses the Covid vaccination even though he has risk factors. A Covid 19 screen was completed 4/19/21 and he declined the vaccination. He verbalized concern that it is the governments way of changing his DNA. CM attempted to educate the member on covid, his risk factors and vaccinations. The member was angry, he stated that the government has been out to get him and that this vaccination is another way to get to him. The CM was unable to redirect the conversation.
