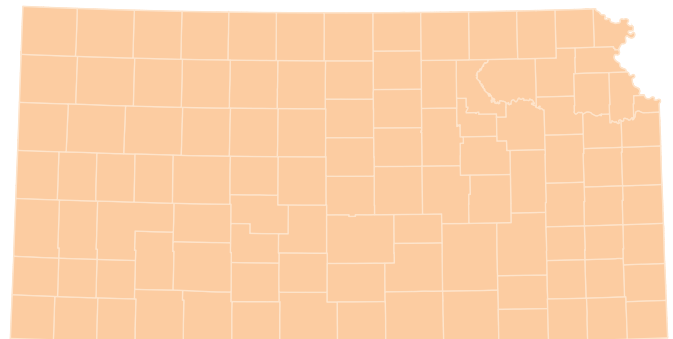

INNOVATIVE PROGRAMS

Over its 10-year existence, Sunflower has partnered with over 300 organizations throughout Kansas to address challenges such as food access, transportation, employment, housing, and access to needed care. In addition, Sunflower supports various community organizations, events and initiatives through \$250K in donations and 500 employee hours volunteering.

DRIVERS OF HEALTH (DOH) AND HEALTH EQUITY

Sunflower is dedicated to helping our members who experience food insecurity, unemployment, and social isolation.

- Since May 2022, nearly 30,000 Sunflower members have completed DOH screenings.
- Since January 2022, the GROW program (GED, Rides, Opportunities and Work) has helped members attain their GEDs and provided resources for employment to more than 1,000 individuals.
- In 2022, 1,500 members received more than \$14,000 of fresh fruits and vegetables through Sunflower’s Farmers Market Voucher program.
