Caregivers Across the Country



Who is Eligible for Services at the AAA?

- 60 and older
- Caregiver at least age 18, caring for an adult 60+
- Certain populations are targeted

Some programs may require an assessment to determine eligibility (UAI, FAI, CARE, CAP)

AAA Core Services

- Information and Assistance
- Caregiver programs details will be provided
- In home services
- Case management
- Nutrition
- Health and Wellness
- Nursing home pre-screening (CARE)
- Assessment for HCBS
- Advocacy

Support Services/In-home Services

*Access Services

- Provides services that help people access support.
- Must be 60+

 Donation Only Examples of service provided: Information & Assistance/referral, transportation, outreach/public education, legal, and case management services

*In-Home Services

- Provides supportive services in the home
- Must be 60+
- Donation only

Examples of service provided: Homemaker and attendant care, home repairs, large clean up, visiting and telephone reassurance

Nutrition Services

Home Delivered Meals

- Provides a hot meal delivered to the home
- Must be homebound and 60+
- Donation Only

Congregate Meals

- Provides a hot meal in a congregate setting
- For adults 60+
- Donation Only

Health Promotion/Disease Prevention

*Health and Wellness Programs

- Intended to improve health and well-being, and reduce disease, disability, and/or injury of an older adult.
- Evidence based program

Examples of service provided:

Walk with Ease, Tai Chi, Enhance Fitness, A Matter of Balance, Diabetes Prevention Program...

Family Caregiver Support Program

- *Caregiver Programs
 - Serves caregivers of any age caring for a adult 60+
 - Donation Only

Examples of service provided:

- Information and assistance
- Counseling
- Support groups
- Caregiver training
- Respite in home, out of home, overnight
- In-home services on a limited basis.
- Transportation
- Caregiver Coordinator

*Each AAA offers services that meets the needs of individuals in their service area

- Understand the caregivers' needs and focus attention on their goals and their identified "care team"
- Maneuvering the complex system – we can help!
- Have a good understanding of resources/eligibility/cost – connecting caregivers with appropriate resources



Examples of Collaboration

- Referrals through Iris
- Referrals directly to an agency
- Assist with options counseling
- A case manager/care manager may be involved in some cases

- Coordination with organizations that offer caregiver services
- Provide information to family members/other care team partners
