Details: Member in-patient at hospital due 36 weeks pregnant with uncontrolled diabetes.

In-patient management for uncontrolled diabetes, remained in-patient until blood sugar is stable and will deliver baby.

Member is a single parent of 2, expecting baby #3, limited support system.

Member diabetic in need of a glucose monitor, 36 weeks pregnant, father of baby abusive, and experiencing financial hardship. Member was able to get her diabetes treated and ongoing prenatal care during her hospital stay. Member was scheduled for a c-section.

Details: father of baby was abusive to member during the last few weeks of her pregnancy. Member reports she was able to get away from the father of baby and is in a safe place. Member currently have a safety plan in place just in case the father of the baby returns.

Social History: (Current living situation, employment status, pertinent legal history, level of education, relationship status, children, support system, etc.)

Details: financial hardship, single mother, minimum social support

Member has a high school diploma, currently unemployed but has a job lined up for when she is released from maternity leave. Member reports being on her own she is now faced with financial hardship. I was able to assist the member with applying for SNAP (Food/cash assistance). Member reports she already had WIC services in place and plans to add the newborn once she delivers.

Member reports she is behind on her rent and needed assistance, informed member about (WERAP) emergency rental assistance program to assist her with rent/utilities. Member was able to apply to the program during the visit.

Member was undecided whether if she was going to breastfeed baby. Informed member of the importance of breastfeeding and explained that she was eligible to receive a free breast pump. I was able to assist member with ordering a breast pump. Breast pump ordered through Edgepark. Member will receive a Madela breast pump within 7-10 business days at her place of residence. Provide member with community resources to assist her with obtaining baby clothing, diapers, and a bassinet.

Pertinent Lab Work: NA

Barriers to Treatment: Multiple in-patient medical admissions for poor management of diabetes. Member did not have a glucose monitor to monitor blood sugar level, member 36 weeks pregnant and lacking baby items, member experiencing financial hardship.
