Member resides in an apartment with her 7 y/o son, denies any concerns of domestic violence and feels safe at home, is employed full-time at a call center, completed GED, has good support from family, especially members mother, father of baby is unknown, reports it is one of two people and discussed plans to have paternity testing completed with provider, is enrolled in WIC, receives EBT SNAP benefits, has enough food, reliable phone and reliable transportation to appointments.

Member verbalizes history of anxiety and depression since 2020, feels symptoms are currently stable, denies history of self-harming behavior or suicidal ideation, denies taking behavioral health medications or currently receiving behavioral health therapy, has seen behavioral health provider in the past and can see that provider as needed.

Treatment Summary (Form of treatment, engagement in treatment, date entered, voluntary, etc.)

Second pregnancy, 1 successful birth previously. Estimated delivery date 12/24/23. History of 1 full-term delivery of 7 y/o son by Cesarean Section due to non-reassuring fetal heart tones at 40 weeks gestation, baby weighed 7 lbs. 12 oz. Currently attends prenatal visits every 4 weeks, has ultrasound scheduled next month for heart views, has severe morning sickness, was prescribed zofran without relief, medication discontinued and current prescription for Phenergan which member does not feel helps so far. Member plans to breastfeed. Per medical record weight gain during pregnancy recommended to be 11-20 lbs due to obesity. Asthma diagnosed in childhood, condition stable but is more bothersome with the severe heat, PCP follows member for asthma. Member denies having dental or vision exams in the last 12 months.

Barriers to Treatment

Time restraints - works full-time and primary caregiver of 7 y/o son.

Financial restraints - reports living paycheck to paycheck.
