

# Opening Behavioral Health Codes

## Specialized Community – Based Rehabilitation Services

Specialized Community Based Rehabilitation services are provided as part of a comprehensive specialized psychiatric program available to all Medicaid eligibles with significant functional impairments resulting from an identified mental health diagnosis or substance abuse diagnosis.

The medical necessity for these rehabilitative services must be determined by a licensed mental health practitioner or physician who is acting within the scope of his/her professional license and applicable state law and furnished by or under the direction of a physician, to promote the maximum reduction of symptoms and/or restoration of a recipient to his/her best possible functional level.

# Provider Qualifications and Responsibilities

## Eligible Providers

Specialized Community Based Rehabilitation services are provided under the direction of a Physician

Licensed Clinical Mental Health Professional (LCMHP)

and

Licensed Mental Health Professional (LMHP)

In accordance with state law, a LCMHP and a LMHP are defined as follows :

An individual who is licensed in the State of Kansas to diagnose and treat mental illness or substance abuse acting within the scope of all applicable state laws and their professional license.

*\*For ongoing reference only the term of LMHP is used for all licensed mental health professionals including clinical licenses.*

## LMHP Licensure Guidance

### Licensed to practice under supervision or direction

#### Licensed Mental Health Professional (LMHP)

- Licensed Masters level marriage and family therapist
- Licensed Masters level professional counselor
- Licensed Masters level social worker
- Licensed Masters level psychologist

# Provider Qualifications and Responsibilities

## Non-Licensed Personnel Guidance

### **Non-Licensed/Paraprofessional providers**

- All non-licensed/paraprofessional providers will be under the supervision of a LMHP, Physician, APRN/ARNP, or PA.
  - The supervising provider will be the rendering/billing provider for claims submission.
  - The supervising provider will ensure all non-licensed/paraprofessional staff qualifications and trainings are on file and available upon request.
- Provider qualifications are listed in the KMAP Mental Health Provider manual for each specialized service.

# Training for Specialized Community Based Rehabilitation Services

## Required state training

All training requirements shall be met in accordance with the established training schedules for the services to be provided.

For services not associated to an identified training element, providers shall frequently review the Kansas Medical Assistance Program (KMAP) Mental Health Provider Manual and the Kansas Department for Aging and Disability Services (KDADS) web site for additional guidance and instructions.

At all times any required training certifications shall be on site and available to KDADS teams and Managed Care Organization (MCO) requests , as applicable for verification of completion.

*\*Providers will be responsible for seeking a Nationally recognized CI training provider and for any training re-certifications for these services. Training certificates should remain with the organization and be available upon request.*

MCU-Harm Reduction (1123108)	Prior to delivery of service

*\*Prerequisite: CI(1065738) and Nationally recognized CI Training*
